Freedom of Information: Right to know request

Thank you for your request for information regarding illegal broadcasting in Suffolk and Essex between January 2005 and January 2012 which we received on 27 December 2012 and have considered under the Freedom of Information Act 2000.


Please note the following information does not include information pre 2007. Information pre 2007 on illegal broadcasting is held on Ofcom's archived system and is not readily accessible as a considerable amount of time would be needed to locate, retrieve, identify and extract any relevant information. Section 12 of the Act provides that a public authority is not obliged to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the "appropriate limit". The appropriate limit is set out in the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004, and is, for Ofcom, £450. That sum is intended to cover the estimated costs involved in determining whether Ofcom holds the information requested, identifying, locating, retrieving and extracting the information from any document containing it. The Regulations provide that costs are to be estimated at a rate of £25 per person per hour.
